CODE OF CONDUCT FOR COACHES

- I will demonstrate the YMCA core values of caring, honesty, respect and responsibility at all times during practice and games.
- I will not use drugs, alcohol or tobacco while in contact with players or on any property that the YMCA is using. Any coach who is under the influence of alcohol or drugs during practices or games will be suspended from coaching.
- I will not criticize players or officials.
- I will accept the decision of the officials as being fair. Should a concern about an official arise, I will refrain from making comments at the game. I will contact the league coordinator following the game in private to voice my opinion.
- I will not criticize the opposing players, coaches or fans.
- I will keep all sports environments safe and clean at all times and follow all YMCA policies and procedures regarding the use of facilities.
- I will not jeopardize a player's health by allowing him/her to enter or re-enter a game once he/she is injured. I will always be alert for any signs that would indicate a safety hazard.
- I will always place the athlete first and winning second.
- I will refrain from using abusive and profane language toward anyone connected with the game or the organization.
- I will play each child equally as mandated by the YMCA, and I will rotate my players equally and fairly.
- I will respond to players, coaches, staff, players, and volunteers with respect and consideration and will treat all people equally regardless of sex, race, religion, and culture.
- I will not transport athletes in my vehicle other than my own child(ren).
- I will not maintain private social media connections or send private, instant, or direct messages to any minor athlete participating in the league.
- In order to protect staff, volunteers, and players, at no time during the YMCA program will I be alone with a single minor child where they cannot be observed by others. I will never leave any player unsupervised.

Please note: To reinforce these standards, coaches receiving technical fouls in games will face consequences that may result in league suspension. Coaches who engage in foul behavior outside of gameplay may result in game forfeits or league suspension. Please take time reading the league handbook to further educate yourself on disciplinary guidelines.

I hereby pledge that I will follow this code of conduct, as well as follow the guidelines from the Youth Basketball League Handbook. Coaches are responsible for conducting a parent meeting to discuss the league's expectations for spectators.

I further acknowledge that the preceding list is not inclusive of all possible risks associated with participation and that said list in no way limits the operation of this Agreement.
