



PARTIES AT THE ELKINS/RANDOLPH COUNTY YMCA

Host your next birthday party at the YMCA! Parties are scheduled on Saturday and Sunday afternoons. Parties are two hours and include one hour in the pool, gymnastics room or qym; and one hour in our party room.

COST:

- \$150.00 for one hour in the pool, gymnastics or gym and one hour in the party room.
- \$90.00 for a two-hour party in the Rotary room.
- A \$35 clean-up fee will be assessed to groups larger than 50 participants.



CANCELLATION POLICY:

The YMCA reserves the right to cancel a rental in the event of a weather emergency (i.e. if the state calls a state of emergency) or if the facility is required to shut down for unforeseen repairs. In the unlikely event that this happens, the renter may choose to reschedule the event or may request a refund.

In the event that a room becomes unavailable due to an unforeseen incident (e.g. the pool closes for unforeseen repairs), the Y will accommodate the party in another room of equal value in the facility.

The renter may cancel the rental with 48 hours notice. A refund will be issued by check within two weeks of the YMCA receiving notice.

If a rental is cancelled without providing 48 hours notice, the rental fees are non-refundable.

SUPERVISION:

All groups will be required to designate an individual, 21 years of age or older, who is responsible for the conduct of the group. Adult chaperones must accompany children in the facility at all times.

CLEAN UP:

At the close of your event, please remove all decorations (e.g. balloons, streamers, etc.) and deposit any garbage in the garbage bins located in the rental areas. Additional garbage bags are available from the member services desk, if required.

STANDARDS OF CONDUCT:

Any conduct contrary to the purpose of the YMCA is prohibited. Smoking is specifically prohibited in all areas of the facility. Consumption of alcoholic beverages and/or illegal drugs is specifically prohibited anywhere on the property or in the facilities. The YMCA reserves the right to dismiss any individual and/or group that does not maintain the rules of conduct.

RESPONSIBILITY FOR DAMAGE:

The individual responsible for the group and the group as a whole shall be responsible for all damages to the facilities, property and/or equipment caused by the group. The group will be notified within 48 hours of the damage and payment required.

LOSS OF PERSONAL PROPERTY:

The YMCA assumes no responsibility for the personal property of individuals or groups utilizing the facilities and/or property.

USE OF YMCA NAME:

Use of the YMCA's facilities does not imply endorsement or sponsorship of any event by the YMCA. Therefore, promotion shall be designed in such a way that no suggestion of endorsement or sponsorship is implied.
