**Applications must be submitted by the conclusion of the player registration window. Prospective volunteers will be notified of acceptance or denial prior to the rostering process.**

Only league-approved and fully trained individuals may interact directly with players and teams during games and practices.

## Code of Conduct for Coaches

- I will demonstrate the YMCA core values of caring, honesty, respect, and responsibility at all times during practice and games
- I will not use drugs, alcohol, or tobacco while in contact with players or on any property that the YMCA is using. Any coach under the influence of alcohol or drugs during practices or games will be suspended from coaching.
- I will not criticize players or officials, or opposing teams, coaches, or fans.
- I will accept the decision of the officials as being fair. Should a concern about an official arise, I will refrain from making comments at the game. I will contact the league coordinator following the game in private to voice my opinion.
- I will keep all sports environments safe and clean at all times and follow all YMCA policies and procedures regarding the use of facilities.
- I will not jeopardize a player's health by allowing them to enter or re-enter a game or practice one they are injured or show signs of distress, injury, or concussion.
- I will always prioritize the development of my players over the desire to win.
- I will refrain from using profane or abusive language toward anyone connected with the game or the organization.
- I will play each child in accordance to minimum playing time rules, and will rotate my players fairly.
- I will respond to players, coaches, staff, and players with respect and consideration and will treat all people equally regardless of sex, race, religion, and culture.
- I will not transport children in my vehicle who are not my own.
- I will not maintain private social media connections, or send private, instant, or direct messages to any minor child participating in the league.
- In order to protect staff, volunteers, and children, at no time during YMCA programming will I be alone with a minor child where they cannot be observed by others. I will never leave any child unsupervised.
- I will work to communicate effectively with parents and staff, and provide notice of any team-specific needs and schedule changes.
- I will abide by league expectations for practices, and to promote fairness within the entire league, will not schedule practices that exceed assigned times or utilizes an unapproved location.

## Volunteer Coaching Requirements

- Attendance at a mandatory coaches' meeting with the league coordinator
- Completion and submission of all documentation from an FBI-conducted background check, including associated payment.
- Participation in player evaluations and the league draft, as assigned
- Completion of required concussion and abuse prevention training (must be renewed annually)
- Signed and submitted child safety policy, liability waiver, and code of conduct

**Upon successful completion of all required training and onboarding steps, coaches will receive a 50% reimbursement of their child's program registration fee.**

## Handbook Acknowledgement

To reinforce these standards, coaches receiving technical fouls in games or who engage in foul behaviors outside of gameplay will face consequences that may result in suspension, game forfeits, or expulsion.

I hereby pledge that I will follow this code of conduct, as well as review and comply with guidelines set forth in the Youth Basketball League Handbook. Coaches are responsible for discussing and reinforcing expectations for spectators.

**ACKNOWLEDGMENT OF RISK** I hereby acknowledge and agree that participation in YMCA programs and use of the facility/equipment comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with participation in activities at the YMCA, including but in no way limited to: (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, and (4) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with participation and that said list in no way limits the operation of this Agreement.

In consideration of my participation in YMCA programming or use of the equipment/facility, I, the undersigned participant, agree to **INDEMNIFY AND HOLD HARMLESS** Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to my participation. I hereby certify that I have full knowledge of the nature and extent of the risks inherent in participation of YMCA programs or use of the facility/equipment and that I am voluntarily assuming said risks. I understand that I will be solely responsible for any loss or damage, including personal injury, property damage, or death, I sustain while participating in YMCA programming or accessing the facility and that by signing this agreement I **HEREBY RELEASE** Releasees from all liability for such loss, damage, or death. I further certify that I am in good health and that I have no conditions or impairments which would preclude my safe participation in YMCA programming or accessing the facility.
